

Summer School 2025 – Terms and Conditions

The Royal Scottish Country Dance Society is under no obligation whatsoever in respect of any personal injury which may be sustained at Summer School. Participants agree to conform to any rules or regulations which may be made from time to time, and which govern their visit to this event.

Bookings will be accepted on the basis that this is a practical dancing course, and attendees' physical fitness should allow them to participate fully in both morning classes for all six days.

Attendance may be for one week or for a maximum of any two weeks. It is hoped that each week will offer something special but those who choose to attend for two weeks may experience some duplication in content and staffing.

Group Bookings for Branches only

A small discount will be available to branch members attending Summer School as a group. Booking will be made by a branch representative and a single group payment made either via the Branch or an individual representing the group. Groups must consist of a minimum of six dancers, all members of the same branch, and all attending in the same week. To benefit from this discount all dancers in the group must be resident in either University Hall or Agnes Blackadder Hall.

Should any member of the group cancel before the refund date, a refund will be made. However, if the cancellation causes the number of participants in the group to fall below the minimum of six required to qualify for the discount, a replacement for the participant will be required or the full fees due to be paid.

Fees

Discounts are available for members of the RSCDS as indicated on the Summer School page of the website.

Non-residents

Attendees who choose to reside other than in University Hall or Agnes Blackadder Hall will be considered as non-resident. Non-residents may attend all classes and social events.

Non-resident option - Morning Classes only

Participants who have selected the morning classes only option may not attend any afternoon or evening events, with the exception of the Welcome Reception on Sunday and the Saturday evening dance, which is included in their fee. They may also purchase tickets for the Thursday evening dances in the Younger Hall.

Non-residents - Music Course

For non-resident participants in the Music Course, where there are both morning and afternoon teaching sessions, the fee includes lunches but no evening meals.

Under 18-year-olds

It is recommended that under 18-year-olds attend Summer School during week 2, Youth Week. This will enable them to interact with other young dancers, as well as with the general dance community.

They must be accompanied by an adult who must be either:

- A parent or legal guardian
- A grandparent
- A named responsible adult

Cancellation Policy

If, due to circumstances outside its control, the Royal Scottish Country Dance Society requires to cancel the Summer School event then all attendees will be informed, and a full refund will be provided. The Society shall assume no liability for any losses resulting from individual pre-booked travel. Participants should ensure they are covered by their personal travel insurance policy – see below.

Refunds

Should a participant have to cancel, every effort will be made to provide refunds up to 31 March 2025. Refunds will not be made for cancellations after this date. All refunds will be subject to an administration charge of £80 per person.

Should a participant have to withdraw for any reason during their attendance period, no refund will be given, nor will they be able to complete their course in any other week.

Insurance

Attendees are strongly advised to have suitable insurance to cover any loss of fees or other expenses in the event of illness, injury or other unavoidable circumstance.

Health

While all Covid rules and restrictions have been lifted in Scotland, it is hoped that participants will continue to use "Covid sense" and consider the health of others by not attending if they feel unwell. Hand sanitiser will not be provided in venues - therefore participants may wish to bring their own.

Photography and filming

It should be noted that filming/photography will take place during Summer School for promotional and archival purposes. The photographs and recordings may appear on the RSCDS website, social media platforms or other publications.
